- If at any stage, it is found that a candidate has furnished false or incorrect information and /or found indulged in misconduct/unfair means, his candidature is liable to be cancelled, without prejudice to the right of the Corporation to initiate appropriate legal proceedings against the candidate.
- After declaration of the Final Results, the candidates selected under OBC-NCL category will have to submit OBC-NCL Certificate in the prescribed format (Annexure-B) issued on or after 01.04.2022, at the time of document Verification.
- After declaration of the Final Result, the candidates selected under EWS Category will have to submit a valid Income & Asset Certificate in the prescribed format (Annexure-C) issued during the financial Year 2022-23 i.e. from 01.04.2022 to 31.03.2023 at the time of Document Verification.
